Prevention - Trainings Sub-Committee Quarterly Meeting Updates		
Regularly Scheduled Meetings: 3 rd Mondays, 3:30pm-4:30pm		
Sub-Committee Goal(s):	Increase detection and screening to connect people to services based on suicide risk.	
Sub-Committee Objective(s):	Trainings to increase effectiveness of suicide risk screenings, assessments and trauma-informed practices. Trainings to support identification and intervention to effective care.	
Last Quarter's Actions:	The Trainings Workgroup is undergoing structural changes to better support the Suicide Prevention Training Trainer Cohorts in Riverside County. This workgroup will now meet quarterly. The trainers for safeTALK, Applied Suicide Intervention Skills Training (ASIST), and Mental Health First Aid (MHFA) will meet together each quarter to discuss fidelity to their respective models, evaluate potential trainings to bring in to Riverside County, and discuss other ways to support the work of the Suicide Prevention Coalition. We are looking forward to this shift and continuing to work toward the goal of training everyone who lives or works in Riverside County in at least one Suicide Prevention Gatekeeper Training!	
Community Partners Needed:	Individuals trained to facilitate suicide prevention gatekeeper trainings such as safeTALK, ASIST, and MHFA.	
Priority Activities this Quarter:	 Create PSA video(s) promoting suicide prevention gatekeeper trainings. Develop plan to share PSA with community (i.e. sponsored social media posts. movie theaters, DMV, doctor's offices, etc.) 	

Prevention - Higher Education	
Regularly Scheduled Meetings: 4 th Mondays, 9:00am-10:00am	
Sub-Committee Goal(s):	Standardize policies and curriculum to promote connectedness and address suicide risk.
Sub-Committee Objective(s):	 Increase education and awareness regarding mental illness and suicide amongst college students and staff. Assist schools with the implementation of trauma-informed practices. Promote increased help seeking behaviors amongst college youth.
Last Quarter's Actions:	 Developed content for first installment of training series for college staff/faculty. Training tool will include a tip sheet and short video focused on strategies to reduce mental health stigma. Self-care techniques are implemented during each meeting and committee members are encouraged to utilize these skills with students, staff, and faculty on their campuses.
Community Partners Needed:	Participation from college faculty/staff from each campus in Riverside County.
Priority Activities this Quarter:	 Establish a strategic plan for disseminating training series on college campuses across Riverside County. Develop video content for future installments of the training series. Develop wellness activities for faculty/staff on college campuses across Riverside County.



Prevention – Engaging Schools Sub-Committee Quarterly Meeting Updates

Sub-Committee Goal(s):	Standardize policies and curriculum to promote connectedness and address suicide risk.	
Sub-Committee Objective(s):	 Implement programs that foster social emotional growth. Develop and implement standardized suicide risk assessment tools and prevention plans. Assist schools with the implementation of trauma-informed practices. 	
Last Quarter's Actions:	 RUHS & RCOE have been providing the following trainings to school staff by request: QPR (Question. Persuade. Refer.), Know the Signs, Social Emotional Learning, PBIS (Positive Behavioral Interventions & Supports) Districts/Schools serving grades 7-12 have a policy on pupil suicide prevention. SPARE (Suicide Prevention and Risk Evaluation) is currently being piloted in three school districts. Received grant funding to support further implementation of tool. 	
Community Partners Needed:	Representation of K-12 Districts (highest priority). School admin, school psychologists, clinicians, and students.	
Priority Activities:	 Build a resource sheet of all the suicide prevention policies for the 24 districts in Riverside County w/ links to the policy. Building a year-long schedule of trainings/workshops to strengthen existing programs that foster social emotional growth. Build implementation plan that includes training, coaching, and fidelity. Work with RCOE Assessment, Accountability, and Continuous Improvement Unit to build measurement tool to evaluate SPARE pilots. 	

• How can other sub-committees potentially help you in your efforts?

Engaging Schools focuses on the full continuum of support for suicide prevention. Other sub-committees can help by assisting the sub-committee with resources, tools, and frameworks that pertain to TK-12 and student serving communities.

What additional supports or resources may be needed?

Resources and supports to increase district involvement. This may include a Google Survey provided to Riverside County School Districts to inquire about the topics around suicide prevention in the areas of needed support, date/time of meetings, and overall frequency of meetings. Additionally, a list of researched-based practices that reduce death by suicide on a shared document provided to Riverside County School Districts.

Intervention Sub-Committee Quarterly Meeting Updates		
Regularly Scheduled Meetings: 3 rd Wednesdays,1:00pm-2:30pm		
Sub-Committee Goal(s):	Deliver a continuum of crisis services across the county and evaluate crisis services to identify gaps in care. Create safe environments by reducing access to lethal means and develop professional competence to reduce risk and promote community safety.	
Sub-Committee Objective(s):	 Improve transition in care of consumers following a hospitalization or a consumer/family contact with crisis system of care. Develop relationships with community partners that are willing to work with the committee to reduce access to lethal means to improve community safety. Develop a recommendation for countywide best practice professional trainings on means safety and consumer care for the consumer with suicidal ideation. 	
Last Quarter's Actions:	 Continued to distribute care transition flyer to crisis services and programs countywide. Received feedback that the flyers have been helpful, as well as, requests for additional flyers to share with consumers. Sub-committee will participate in a Means Safety pilot program organized by the statewide Striving for Zero initiative. Pilot is set to launch in summer 2023. Sub-committee will select "ambassadors" across the county to collaborate with gun sales stores and gun ranges to address the issue of suicide prevention and firearm safety. 	
Community Partners Needed:	Trainings sub-committee	
Priority Activities:	 Continue distribution of care transitions flyers and collect feedback from partners on consumer and family responses. Determine "ambassadors" for the Means Safety Pilot program. Invite various community member partnership in development of training materials

How can other sub-committees potentially help you in your efforts?

They can support us in the recruitment of survivors of suicide loss to facilitate support groups. We could also use support in identifying volunteers for TIP who will directly support survivors immediately after the loss.

• What additional supports or resources may be needed?

TIP continues to try to expand their contract to other parts of the county. Desert Region is a large focus still as there is no TIP services there. Perhaps the Effective Messaging subcommittee could help TIP get an article in a local desert paper if they have a contact. If residents were interested in having TIP in their area, they would advocate to their representatives. We could also use support in establishing messaging to get the word out about the recruitment of volunteers to run SOSL support groups.
