- iii. At the next meeting, we will debrief on how social media and email roll out went for each site.

c. Debrief on SPC Conference

- i. The general consensus was that the venue and food were great, and it was nice to meet and learn about other subcommittees.
- ii. During the tabling portion, they found that guests who were interested in joining were not from higher education institutions, but rather wanted to provide trainings or collaborate with us.
 - i. How do we feel about extending the invitation to non-higher







- a. It was agreed that we should aim to strengthen our relationship with institutions within the county first, then we can consider inviting more folks to the table, such as students and CBOs. In the meantime, we can invite these folks to provide trainings.
- b. However, some community colleges do not have a health/wellness center, so not everyone has a direct role that may allow them to join our subcommittee.
 - i. Potential solutions:
 - Lynnette will contact therapists on campuses to serve as representatives for their site.
 - Connie and Lynnette will also contact colleges to see if there are any interns (for health education or MSWs) interested in joining.
- c. The institutions that we are hoping to include in our subcommittee are College of the Desert, Loma Linda University (Murrieta campus), and Mt. San Jacinto
 - We will attempt reaching out first. If that doesn't work, we can ask the coalition co-leads to contact them as well.
 - ii. We are also open to inviting folks from graduate institutions, such as medical and law schools.
 - We should consider inviting representatives from satellite campuses that have students living with the county, such as Cal State San Bernardino in Palm Desert.
 - 1. Sarah will get in contact with folks working at the CSUSB Palm Desert location.
- d. Document: Postvention A Guide for Response to Suicide on College Campuses
 - i. This document will be sent out to the subcommittee to learn more about postvention.

iv. Next Steps / Questions / Comments

a. STEM and Criminal Justice students seem to be hesitant to seek help, as they are afraid it will show up on their record or will need to be disclosed upon applying











- i. We need to ensure faculty and staff are trained to help students and themselves.
- ii. Sarah shared that after reviewing medical school applications, there is one self-disclosed question asking about one's past struggles with their mental health. It is entirely within the student's discretion how they choose to answer the question.
- b. It was suggested that we should make a calendar with upcoming events and trainings for folks to stay informed. We can also include measurable goals for us to meet.
 - i. We should try to make more videos or have additional collaborative efforts. An example could be each school offering to host a cultural mental health panel in certain months.
- c. Connie shared that there is a CA Mental Health grant that will be opening soon for new applications. She will share more information with the subcommittee once the application opens.
- d. Next meeting is December 18th from 9:00-10:00 am
 - Agenda items include a debrief on the email and social media roll out of the "How to support a student in distress video", updates after contacting more school representatives to join our subcommittee, a plan for our next video, and discuss our subcommittee goals for the next quarter.
