- The following is a list of items that were shared:
 - o Resources
 - -Share resources for suicide prevention
 - -Create culturally relevant information when linking resources and materials
 - -Provide representation in materials and resources shared
 - -Share inclusive resources for leaders and individuals and individuals within the religious community
 - -Provide relevant / present day/ relatable material
 - -promote resources
 - -make all materials and resources accessible to adults and teens
 - -create assessable /relatable content to all age groups, ability, and demographics that are gender neutral
 - Engage youth through peer-to-peer communication as form of prevention to increase engagement. (Engaging schools work group: Get schools and teens onboard to help those who are struggling with suicidal ideation and connect them to resources.
 - o Increase personal and external knowledge in suicide prevention
 - o Educate community with emphasis on self-love and care.
 - o Bring awareness to suicide prevention, educate, encourage asking for help, and reduce the negative stigma
 - Support and encourage accessing help and treatment for all.
- Objectives, action plan, decision on which objectives should be primary focus, and conversation surrounding tying action items to the Strategic Approach detailed in Suicide Prevention Strategic Plan will continue at later date.
